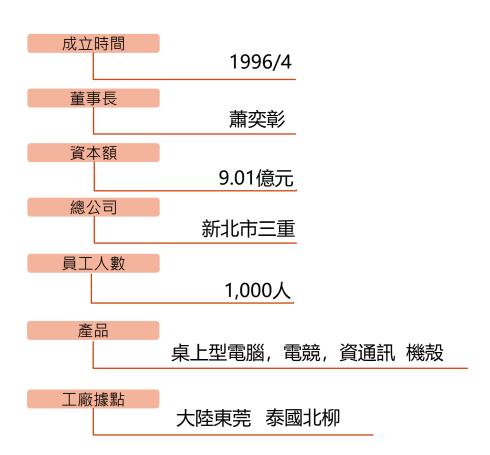

▶ NVIDIA 新一代高階顯示卡RTX 50 系列及多項3A遊戲 即將問世,高效率的散熱及充足散熱需求提升,已與 客戶完成開發。2025年營運動能及業績有望更勝今年, 目前都已展開備戰策略。

NVIDIA's next-generation high-end graphics cards, the RTX 50 series, and a number of triple-A games are about to be released, and the development of high-efficiency heat dissipation and sufficient heat dissipation needs has been completed with customers. The Profit in 2025 are expected to be better than this year, and the preparation strategy has been launched.

- ▶ 旭品與散熱大廠合作開發4U CDU,目前已進入測試階段,並預計2025年第二季再添助力。
- 水冷方面己完成中價位產品線,同步開發高階產品也進入最後驗證階段,有待2025年Q2完成一系列產品,為營收注入成長動能。

Casing has cooperated with a major heat dissipator to develop a modular 4U CDU, which has entered the testing stage and is expected to make more profit in Q2 in 2025.

In terms of water cooling, the mid-price product line has been completed, and the simultaneous development of high-end products has also entered the final verification stage, and a series of products will be completed in Q2 2025 to inject growth momentum into revenue.

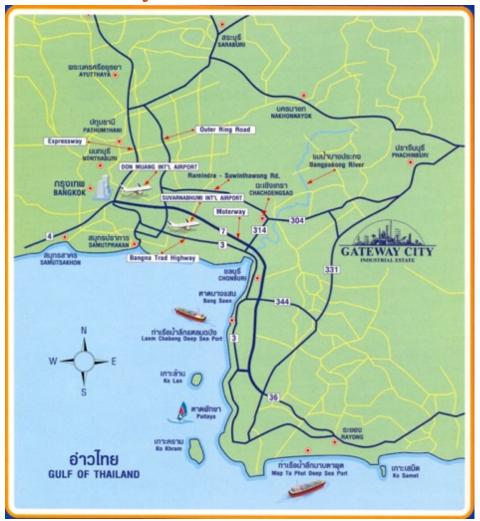
